Documents required:

1. A copy of the Articles of Association / Memorandum of Association.
2. A copy of the Commercial Registration (CR).
3. The membership of the Board of Directors and authorized signatories list.
4. A copy of licenses obtained by the applicant from the competent authorities for its activities.

Notes:

QCSD consider membership applications and make its decisions in accordance with QCSD rules as follows:

1. QCSD shall, upon receipt of the membership application that meets the requirements, take its decision by acceptance or rejection within a maximum period of thirty days from the date of the application and it shall notify the applicant of its decision by post and e-mail. Not responding during that period shall be considered as rejection of the application.
2. In case the application is approved, QCSD shall inform the applicant and the authority of its decision. It shall include the date of approval. The decision shall come in force only when the membership agreement is duly executed, not later than fifteen days of the decision.
3. In case the application has been rejected, the applicant may re-submit the application to QCSD in writing to reconsider its application within the fifteen days from the date of notification of the rejection. QCSD shall decide on the application and inform the applicant within seven days from the date of receipt and in case the application is rejected, the applicant may appeal to the Authority on the decision of rejection, according to the norms of grievance of the Authority.
